**Vendor Application Information - Rules & Conditions**

1. There are two categories of booths:  
**(A) Arts & Crafts - No flea market or commercial items allowed. Items must be handcrafted, hand-finished or handmade. Violators will be asked to leave.**  
**(B) Food - only food listed on form will be allowed. Violators will be asked to leave. Limited to first 10 food vendors – NO DUPLICATION.**
2. All applicants must fill out an application, **stating exactly what type of items will be for sale in the booth.** Spaces are assigned first come, first served. **Early bird discount deadline May 31st. Final deadline – June 15 th.** ENTRY FEES MUST BE PAID WITH APPLICATION. *No booths will be reserved for anyone until fees are paid.*
3. The Frio Canyon Chamber of Commerce reserves the right to deny entry due to unacceptable merchandise or lack of available space. All booths requiring electricity will have an additional \$10 fee and must furnish their own extension cords. You must furnish your own canopy, tables, chairs, etc. Food vendors – please bring your own trash container.
4. **All booth sizes are approximately 10' x 10'.** This is an approximate size for your information to help you plan for arranging props to display your arts and crafts.
5. Booths will be open from 9:00 AM to 4:00 PM. No electricity will be furnished before or after these hours. ALL BOOTHS MUST BE SET-UP BY 8:00 am OR THE SPACE WILL BE FORFEITED. NO BOOTH WILL OPERATE ANY LATER THAN 4:00 PM.
6. You may unload at the Courthouse Square anytime up to 8:00 a.m. on **Saturday only. Rain or Shine – NON-REFUNDABLE AT ALL**
7. **All displays and food booths must be removed by 6:00 p.m. on Saturday.**
